OVERVIEW

This Manual is published in terms of Section 51 of the Promotion of Access to Information Act, 2000 (Act No. 2 of 2000) ("the Act"). The Act gives effect to the provisions of Section 32 of the Constitution, which provides for the right of access to information held by the State and to information held by another person or entity, where such information is required by someone to protect his/her rights.

This manual serves to inform members of the public of the categories of information the practice holds. Access to the records and information is not automatic. Any person, who would like to request access to any of the above records or information, is required to complete a request form, which is attached to this Manual.

INTRODUCTION TO THE PRACTICE

Moore Miller Physiotherapists Inc. is an incorporated practice whose principle business is rendering physiotherapy services in both land-based and aquatherapy-based practices.

THE GUIDE OF THE SA HUMAN RIGHTS COMMISSION

The SA Human Rights Commission (SAHRC) has, in terms of section 10 of the Promotion of Access to Information Act (PAIA), developed a guide containing information reasonably required by a person wishing to exercise or protect any right in terms of PAIA. This guide contains amongst others the following information:

- The purpose of PAIA;
- The manner, form, and costs of a request for access to information held by a body;
- Assistance available from Information Officers and the SAHRC;
- Legal remedies when access to information is denied;
- When access to information may be denied; and
- The contact details of Information Officers in the National, Provincial and Local Government.

HOW TO REQUEST ACCESS TO RECORDS HELD BY MOORE MILLER PHYSIOTHERAPISTS INC.

Requests for access to records held by Moore Miller Physiotherapists Inc. must be made on the request forms that are available from the practice, information officer, the practice website, or from the SAHRC website (www.sahrc.org.za).

When a record is requested, please note that:

- The fees are prescribed for requesting and accessing information and records held by the practice. A requestor (other than a personal requestor) is required to pay the prescribed fee of R50 before a request will be processed. Details of these fees payable may be obtained from the Information Officer. The fees are also available on the website of the SAHRC. A requestor may be called upon to pay the additional fees prescribed by regulation for searching and compiling the information, which has been requested, including copying charges.
- The fact that information and records are held by the practice as listed in this Manual should not be construed as confirming upon any requestor any right to the information or record. Access to the requested records or information or parts of the records or information may be refused in terms of the law.
- The Request Form known as “**Form C - REQUEST FOR ACCESS TO RECORD OF PRIVATE BODY**” must be completed. It can be obtained from our website, our Information Officer, on the SAHRC website (www.sahrc.org.za) or on the website of the Department of Justice (www.justice.gov.za) under “PAIA” and “forms”.
- On the Request Form all details must be completed, including the right the requestor wants to protect by requesting the information. The requestor must provide sufficient detail on the request form to enable the Information officer to identify the record and the requestor.
- If the requestor is acting on behalf of someone else, the details of the other person as the one who has authorised the request must be included and the requestor must submit proof

of the capacity in which the requestor is making the request to the satisfaction of the Information Officer.

- The requestor must state in which form (inspection of copy, paper copy, electronic copy, transcript, etc) s/he wants to access the information.
- If the record is part of another record, the requestor will only be allowed access to the part(s) that pertains to the information s/he wants or is entitled to, and not the rest of the record.

All requests will be evaluated against the provisions of the Act. The Act allows the Information Officer to refuse access on grounds stipulated in the Act. A requestor can, for example, not access another person's confidential information, or trade or commercial secrets of a business.

An answer on a request for information must be made within 30 days of the request, and if not granted and the requester is not satisfied with the reasons for the refusal of access, s/he can approach the courts within 30 days of the request being refused.

VOLUNTARY DISCLOSURE/RECORDS AUTOMATICALLY AVAILABLE

The following information is made known automatically and thus persons do not have to request such information: The practice terms and conditions, our billing policy, commonly used fee price list, HPCSA ethical rules and guidelines and the practice code of conduct. These are available on the practice website www.mooremillerphysio.co.za and/or at the practice reception.

RECORDS AVAILABLE IN TERMS OF OTHER LEGISLATION

Information is available in terms of the following legislation to the persons or entities specified in such legislation, as well as the specific protections offered by such laws. As legislation changes from time to time, and new laws may stipulate new manners and extend

The Companies Act 71 of 2008; Income Tax Act 58 of 1962; Value Added Tax Act 89 of 1991; Labour Relations Act 66 of 1995; Basic Conditions of Employment Act 75 of 1997; Employment Equity Act 55 of 1998; Skills Development Levies Act 9 of 1999; Unemployment Insurance Act 63 of 2001; Electronic Communications and Transactions Act 25 of 2002; Telecommunications Act 103 of 1996; Electronic Communications Act 36 of 2005; Consumer Protection Act 68 of 2008; Broad-based Black Economic Empowerment Act 53 of 2003; National Credit Act 34 of 2005; Compensation for Occupational Injuries and Diseases Act 130 of 1993; Occupational Health and Safety Act 85 of 1993; Promotion of Access to Information Act 2 of 2000; Protection of Personal Information Act 4 of 2013; Road Accident Fund Act 56 of 1996; Skills Development Act 97 of 1998; Unemployment Contributions Act 4 of 2002.

The Health Professions Act 56 of 1974, National Health Act 61 of 2003; Medical Schemes Act 121 of 1998; Medicines and Related Substances Act 101 of 1965; Children's Act 38 of 2005; Mental Healthcare Act 17 of 2002; Choice on Termination of Pregnancy Act 92 of 1996; Sterilisation Act 44 of 1998; etc.

RECORDS HELD BY MOORE MILLER PHYSIOTHERAPISTS INC.

The practice holds records in the following categories. The fact that a record type is listed here does not necessarily mean that we will disclose such records, and all access is subject to the evaluation processes outlined herein, which will be exercised in accordance with the requirements of the Act.

Internal records relating to the practice and business which includes the practices' founding and other documents, minutes and policies; annual and other reports; financial records; operational records, policies and procedures; contracts; licences; trademarks and other intellectual property; marketing records; other internal policies and procedures; internal correspondence; and statutory records.

Personnel records which includes records relating to all employees, contractors, partners and directors. It includes personal files and similar records; records third parties have provided to us about their personnel; employment contracts, conditions of employment; workplace policies; disciplinary records; termination records; minutes of staff meetings; performance management systems and records; and all employment-related records and correspondence.

Patient records which includes patient lists; health records; funding records; agreements; consents; needs assessments; financial and accounts information; research information; evaluation records; profiling and similar information. ***It must be noted that, in the health sector, personal and patient information are confidential and protected by legislation and ethical rules, and disclosure can only take place, if at all, within those frameworks.***

Supplier and service provider records which includes supplier registrations; contracts; confidentiality agreements and non-disclosure agreements; communications; logs; delivery



records; commissioned work; and similar information, some of which might be provided to the practice by suppliers and providers under service and other contacts.

Technical records which includes manuals; logs; electronic and cached information; product registrations; product dossiers; health professions council / statutory body records; approvals, conditions and requirements; trade association information; and similar product information.

Third party information which may be in the practices' possession, but which would be subject to the conditions set in relation to such possession.

Environment and market information which includes information bought, publicly available information and commissioned information which pertains to the specific sector and market of the practice and factors that affect the business, professional and healthcare environment.
